2023 Southern Conference on Homelessness and Housing

The 2023 Southern Conference on Homelessness and Housing was held at the Miramar Beach Conference Center in Florida, October 25-27, 2023. The conference's primary objective was to convene a diverse group of stakeholders, including housing developers, homeless program managers, case managers, and state and local government representatives to collectively address the persistent challenges related to poverty and the insufficient availability of safe, decent, and affordable housing in the region where people living with HIV/AIDS needed assistance. There was knowledge sharing, and policy development, through the collective efforts of diverse stakeholders to contribute to meaningful and sustainable solutions. Participants had the opportunity to share insights, best practices, and lessons learned from their experiences in addressing homelessness and housing issues. This collaborative exchange of information was valuable for informing and implementing effective strategies.

Special Projects

- Request for Proposal (RFP) is underway and will allow for the identification and inclusion of new organizations that can bring diverse perspectives, expertise, and services to HIV client care. This diversification will contribute to a more comprehensive and responsive approach by addressing the needs of the community. We will be taking proactive steps to move the RFP process forward and efficiently in early FY'23-24 to ensure that all stakeholders are informed, engaged, and aligned with .the process.

EIS Work Group

We have successfully utilized the '5 Whys' Root Cause Analysis tool to identify the primary factors influencing retention in care. This in-depth analysis has revealed key challenges such as lack of appropriate housing, food and dietary issues, mental health concerns, physical health challenges, and substance abuse. Understanding these root causes positions us to implement targeted and comprehensive interventions aimed at improving retention and addressing the broader well-being of the individuals in our care. One key learning from our Root Cause Analysis using the '5 Whys' is the effectiveness of addressing one issue at a time. By concentrating our efforts on a singular problem, we can thoroughly examine and understand its root causes, enabling more targeted and impactful interventions.

Special Projects

- **Media Campaign:** This is a proactive and impactful strategy to assist with reducing HIV cases and promoting awareness in our communities. As for the Bus Wrap, we will design and implement a visually engaging theme that will feature key messages about accessing HIV care. We will also ensure that the bus routes cover the transitional grant areas for maximum visibility. The testimonial videos will feature individuals living with HIV/AIDS who have had positive experiences accessing care. These videos will humanize the campaign, providing real-life stories that resonate with the community. We are very hopeful to diversify the testimonials to represent different demographics within the transitional grant areas. The overall goal is to educate individuals on how to access free testing and care services. Our videos will provide step-by-step guidance on the process, locations, and benefits of getting tested and accessing care.
- **Challenges:** We may need to come up with innovative ways to develop educational materials and campaigns that dispel myths and misconceptions about HIV/AIDS while increasing awareness about the realities of living with HIV and emphasize that individuals with HIV lead fulfilling lives. Or, allow individuals to share their testimonials anonymously if they are not comfortable revealing their identities. After discussion with our Project Officer, we will be increasing our monetary incentive as we solicit interviewees.
 - Increased incentive to \$500 per participant (from \$100)
 - Will create "Stigma Campaign" to specifically help address and overcome barriers caused by stigma relating to HIV and AIDS

Sub-Recipients

Hope House

- Hope House has achieved certification as a Mental Health Center, providing mental health services and support to people living with HIV/AIDS.
- Client Surveys: Hope House involves clients through surveys, allowing them to provide feedback on services and programs.
- Grief Group: There is a grief group available, recognizing the importance of addressing emotional well-being and supporting individuals who may be experiencing grief.
- Food Pantry: The food pantry serves as a resource for individuals in need of food assistance.
- Regional One Testing Schedule: Monday, Wednesday, Fridays: Testing available
- Tuesdays, Thursdays: Backup tester will be available.
- Hope House collaborates with Job Corps to assist with linkage and education.
- Hope House partners with various agencies, emphasizing the importance of collaboration within the community to better serve the needs of individuals living with HIV/AIDS.

Friends for All (FFA)

- Friends for All (FFA) Friends for All mobile unit has been delivered and is equipped to provide HIV testing services, Antiretroviral Therapy (ART) provision, and educational resources contributing to increased accessibility and outreach efforts. The mobile unit will play a crucial role in reaching communities in high-priority zip codes with elevated rates of HIV.
- By focusing on high-priority zip codes, the mobile unit aims to make a significant impact on HIV testing rates, early detection, and access to necessary therapies. This approach aligns with public health strategies to reduce HIV prevalence and improve overall health outcomes.
- The inclusion of both testing and ART therapy services underscores a commitment to a comprehensive care model. This not only addresses the immediate need for testing but also ensures that individuals diagnosed with HIV have access to necessary treatments.
- Collaborating with public health agencies, local organizations, and healthcare providers will enhance the impact of the mobile unit. These partnerships will strengthen the overall response to HIV in the community.

Nate Boutte: You said you were using the “5 Whys” Root Cause Analysis, and I’m wondering if you have any barriers with the actual Root Cause Analysis itself, or are you just finding a bunch of root causes?

Shirley Terry-Lewis: When we first started it was craziness. With us, we realized with 18 sub-recipients we meet together, and we start the PBSA, with the Five Why’s we ended up in a web because all agencies kind of did things differently, so it just got crazy. So, what we learned in studying the “5 Whys” was that it’s OK to say, ‘this is not going to work’ and it’s OK to start back over. Let’s tackle one issue at a time, let’s just start with one thing because if we follow it as we were taught to do it was just out of hand. I hope that helps.

Nate: It did, but now I’m curious. Have you been told the story of the Lincoln Monument with the “5 Whys”?

Shirley: No.

Nate: There was a problem with the monuments in D.C. where they were falling apart, so they did the “5 Whys” to see why they were falling apart. They determined it was the cleaning process that was deteriorating them, so then they had to ask why they were using those particular cleaning materials/processes, and they said it was because it was the only thing that cleaned the bird poop off. Then they asked, ‘well why do we have so many birds pooping on them?’, and they said it was because there were so many insects attracted to the monuments that it attracts the birds. So then, they had to ask, ‘what attracts the insects so much’ and they found out it was the lighting that was used. Then they decided to change the timing on the lighting and the lighting source and that became another whole issue. I’ve seen it happen before where you bring in a lot of people and you lose track of the original problem, and you start bringing in other problems and you never get to the root cause of the original problem. So, the second question is based on the answer to the previous question, it’s no longer the previous question.

Shirley: So, in essence what you’re saying is with all the barriers that we came up with we said, “Ok let’s do one”, so we take that one, and we apply the “5 Whys” to that one.

Nate: Yes. Call me if you have questions, I’d love to help with this kind of stuff.

Shirley: Thank you, Nate.

OLD EHE BUSINESS

Nate: World AIDS Day activities (awards, people/orgs, etc.) would make for easy, rewarding posts, could hashtag orgs to share, share photos, etc. spread the message. (“How did you commemorate World AIDS Day? Here’s what we did...”)

Nancy Brownlee: Highlight of orgs that are funded and what they are doing for the holidays, or how they’re contributing to ending the epidemic, plans for the new year, etc. May be too late not, but could have been a holiday special, good way to wrap up the holiday season.

Elizabeth: I think that’s a great way as well. We will keep this in mind for next year.

Sienna Spight: I know someone mentioned it earlier and we talk about it almost every meeting, but “Stigma”. I’m on social media a lot this past week and I’m sure we all saw things going around about the new positives in Shelby County and things like that. And something to combat some of those, or to open up those conversations outside of our network. I know we have our things that we send to each other and what-not, but things we could share with others outside our network would be helpful to spread the message with the public, not just in our organizations.

I know we had the “Know Now” campaign a few years ago that was more focused toward the younger audiences, so maybe bringing back something like that, updated, would be helpful.

Shirley: You also mentioned “stigma”, so are you wanting to reintroduce, or go back to a campaign in reference to dismantling stigma, is that what you’re saying?

Elizabeth: I think she’s wanting to see a united front with EndHIV901 being part of opening up those conversations. (Sienna agreed) These are great suggestions and exactly what we need to be doing as a Community Advisory Board.

NEW EHE BUSINESS

End HIV 901 CAB Engagement Activity (by Roll Call)

- **What skills do you bring to our advisory board?**

Crystal: Expertise as an HIV Clinician; Working as an HIV Practitioner for 7 years.

Jenieya: I work with the communities, and I bring different perspectives from people in the communities in relation to outreach.

Light: I'm a people person and I like to do stuff, so just point me in the right direction and I'll do the job. I also have some living experience as far as substance use disorder, so I really connect with a lot of the population that we serve.

Eddie: I bring a community-based perspective with former experience as the EHE Coordinator for the originally funded EHE entity, speaking in the capacity of TDH.

Lisa: I bring a medical case management background, as well as a management background. I am also very empathetic with what we deal with every day and am very personal with the clients.

Nancy: I bring a sense of realness, not associated with any of the orgs that are present, so my networking and the conversations that I have or people that I connect with, and just the passion that I have for the work itself is different from others. Sometimes I'm the outsider looking in and I think "this is what I'd like to see, and this is what could make it better", and being innovative in that manner.

Nate: Most of what I've been doing so far is just the learning process. My background is not in social work or in the field, per se, so I learn so much from everybody who is able to give me what's happening in the real world on the street in the club, on Grindr, etc., etc., that type of thing, is very eye-opening for me. I really got into Maslov's Hierarchy of Needs based on information that came out of this because by training as far as skills that I bring to the CAB, I've been a Pharmacist for 15 years now and from my very first Pharmacist job I was working at an HIV Center for Excellence, and I was also teaching a class at Friends For Life every other week, working with people living with HIV and it has really been a passion of mine for a very long time. I bring 15+ years of clinical experience in working with HIV, plus I can also do TV, radio, and other media work because I had that responsibility in my position with Walgreen's, so I can now incorporate that in my current job. If you need someone who can be a spokesperson for radio, TV, or other public appearances, etc. I have experience of working in front of the camera and am versed in speaking about working with HIV.

Olliette: I've been in the non-profit arena – administrative & program development, and I understand the challenges of our grantees and the efforts of the EHE campaign. Currently I'm a management consultant for non-profit orgs so I think I understand how to help those orgs face the challenges and opportunities to make them successful. I worked in domestic violence field for many years and saw the intersection when HIV began to impact DV victims and their families, so I bring that unique perspective as well.

Sienna: I bring personal and professional perspective from a person living with HIV for almost 13 years, as well as having work in EIS with Christ Community and what used to be Friends For Life. Volunteered for projects with Shelby County Health Dept., St. Jude, serving in a lot of different capacities.

Tomekicia: I've worked in a lot of different areas in multiple agencies related to HIV, so I think I have a good understanding of what agencies face when looking at challenges such as funding, strategic partnerships, developing the right team, legal issues, etc. My best quality is the ability to collaborate with agencies and people from all walks of life and find common ground and work outward from that.

- **How can you better support End HIV 901 in 2024?**

Nancy: Be more present, more engaged in the outreach activities that occur outside in the community.

Light: I love social media and I take a lot of pictures, so being more active on social media and connecting with other individuals from the CAB, trying to get some projects together. Not great communicating, (hate email!), but I love showing up at events and collaborating with people in person. Try to be more active in person with other people and events.

Nate: Would like to be more organized in sharing events and information on HIV-related items from other areas with Memphis/Shelby County area.

Crystal: I'd like to see our group get together to do a service project or have an opportunity to get together in person somehow. I think it would help us coalesce as a group and feel more connected, maybe once or twice a year.

Elizabeth: I think the best way that I can support all of you is through collaboration with United Way to make sure that your voices are heard and really turning the mic over to you instead of listening to me talk. So, giving you all the platform to speak and be heard on the things that matter to you, and helping to implement those things that you think need to get done.

Eddie: Support the CAB by making sure that future dates are added to the calendar.

Sienna: Be more present at meetings and outreach activities in the community. Collaborating with other orgs and beings "hands on" again like I was before COVID.

Shirley: I'm really interested in advocating with consumers, so I'd like to find ways to engage with more individuals in the community, create an advocacy program to help support and better educate members of the community.

Jenieya: Do a better job of sharing the information that comes through these meetings within my organization's social media posts and advertising, outreach activities, etc.

Taylor Blackwell: I'm still new to this, but I think the best thing I can do is to increase my knowledge of HIV and the work that is being done. From what I can see there is a lot of work still to be done so I think the best thing I can do is to extend my knowledge and work toward combatting that with other community partners.

Teresa Cook: Attending more CAB meetings and also being more involved in the community with Memphis region and outreach activities. I don't reside in Memphis, so I'll have to travel a little bit, but that's an opportunity for me to get more involved in this area.

Latrice Pichon: A better integration of the research and implementation work that we're doing with the CDC-funded projects that we have: 1) Rapid ART interventions, 2) Addressing Stigma with Black churches in the Mid-South, and 3) How to improve linkage to PrEP and HIV testing at Syringe Service Sites. Another thing, because I'm an academic and faculty at the University of Memphis Public School of Health, is to try and figure out a way to improve our workforce development and get more of you to apply for our MPH or doctoral program, and our undergrad program. Those would be the areas I think I could strengthen for 2024.

Lisa: I think the best way for me to better support for 2024 is that there seems to be a bit of a difference from Tennessee to Arkansas and I'm looking for ways I can share to benefit Arkansans.
